Lester Golden, 80, passed away on Monday Jan. 18, 2010. Born and raised in Brooklyn, NY, Mr. Golden lived in Brooklyn for many years before moving to Marlboro, NJ 25 years ago. He was a teacher, assistant principal and principal for the New York City Board of Education for 31 years. He then worked for the Council of Supervisors & Administrators in New York for 8 years retiring in 1995. He was an active member of the Retired Supervisors Union after his retirement. Mr. Golden also was an active member of Greenbriar at Marlboro, including leading a biweekly current events discussion group for the last 13 years.

As a leader among fellow educators, he energetically developed and oversaw programs that enriched the lives of high school youngsters. He left an enduring stamp on the work of his professional associations, and the Council of Supervisors and Administrators of New York City. As the leader of the New Jersey Retiree Chapter, he initiated and developed programs for the betterment of its members. Those programs are now beginning to flourish.

He is survived by his loving wife, Thelma of 55 years; a daughter, Dr. Roni Golden of Freehold, NJ; two sons, Larry and his wife Ellie of Morganville, NJ, Richard and his wife Robin of Larchmont, NY; two sisters, Violet Geller and Lillian Pfeffer, both of Delray Beach, FL; and 8 grandchildren.

Retiree Q&A from Doug Hathaway, Ph.D. (reprinted from CSA News)

QUESTION: I am a retiree currently enrolled in the SIDS dental plan. I will be moving to Arizona this winter. Are there any SIDS dentists in Arizona?

ANSWER: Unfortunately, we do not have SIDS-participating dentists in Arizona. You may remain in the SIDS plan and receive reimbursement according to our schedule of allowances. If you do this, you are responsible for any charges beyond the amount reimbursed. If your spouse is a retiree with dental coverage, you can coordinate benefits and receive "double" reimbursement, which will help cut your out-of-pocket costs. As an alternative, you might want to consider the Delta Dental HMO. You must select a primary dentist from Delta's list, but your out-of-pocket costs, particularly for major procedures such as crowns and root canals will likely be less than with the SIDS plan. (Please see the information elsewhere on this page for instructions on how to request information on Delta or other plans.)

QUESTION: I am a Medicare-eligible retired Principal, and received my Medicare Part B reimbursement. I had over \$120 per month deducted from my Social Security check in 2008 to pay for Medicare Part B, but only received reimbursement for \$96.40 per month. Why didn't they give me the full amount? How can I get what is owed me?

ANSWER: You received the basic reimbursement that goes to everyone, but you are also correct that you are owed money. The extra amount is referred to as IRMAA (Income Related Medicare Adjustment Amount), and to get it back means a little bit of paperwork. On your check stub were instructions for claiming the IRMAA amount. You'll have to submit documentation showing that you were informed of the extra amount as well as the 1099-SSA form you received since January showing how much you actually paid. QUESTION: I am a retired Principal and I am eligible for Medicare. I recently had several doctors tell me Medicare rejected my claim, indicating I was still employed and that Medicare was my secondary coverage. What happened and what do I do?

ANSWER: You were caught in a system glitch caused by one of Medicare's outside vendors. Wellpoint (the company which owns Empire Blue Cross/Blue Shield) sent information to Medicare in April incorrectly indicating that a number of participants were still employed. Since Medicare is secondary, if someone over 65 is still working, Medicare rejects the claims and directs they be sent to the primary carrier. If you call Medicare (I-800-MEDICARE) and speak with the Coordination of Benefits Unit, someone should straighten out your account. Please note: It may take two weeks for all the data systems used to be properly updated so ask your doctors to wait two weeks before resubmitting your claim.

QUESTION: I am a retired Assistant Principal living in Florida. I received a check for \$480 last week. I do not recall sending in a claim to the Welfare Fund. Not that I am complaining, but why did I receive this check?

ANSWER: Based upon your question, my crystal ball indicates that you or your spouse, or both of you, are Medicare-eligible and enrolled in the GHI Enhanced Medicare Part D drug plan. Since the city prohibits us from reimbursing prescription drug co-pays for participants in this plan, the fund automatically sends a check for \$40 per month for each month you, your spouse, or both, were participants in that drug plan. At the present time, we only reimburse for one person in a family even though both may be participants. You were a participant for 12 months in 2008, thus the check for \$480. These checks were mailed in mid-February, so if you have not received a check and feel you should have, please call the Welfare Fund and we will investigate.

QUESTION: I am a retired Assistant Principal who turns 65 on Feb. 22. What happens to my GHI plan when I become Medicare eligible? What about Medicare Part D? I'm sure you've answered this before, but I do not recall specifics. Could you answer it one more time?

ANSWER: I once joked that this was the second most popular question I am asked, after "Where is my check"? Over time, it has actually become the most popular question, so let's answer it again. About three months before your 65th birthday, you will receive a mailing from the Social Security Administration and the city Office of Labor Relations. Social Security will offer you the opportunity to enroll in Medicare Part B. If you are retired and have no benefits elsewhere from a second job or through an employed spouse, you MUST accept Part B. Sign the enclosed ID card and send a copy to the NYC Office of Labor Relations, Medicare Premium Reimbursement,40 Rector St., 3rd Floor, NY, NY 10006. The city will reimburse any payments you make over the base Medicare Part B deduction – \$96.40 a month in 2009 – in August of the following year, i.e., 2009's reimbursement will be mailed in August. Your city-provided health plan will automatically become a Medicare supplemental policy. Your prescription drug benefit will automatically become that health plan's Medicare Part D drug plan, eliminating the need to enroll in another drug plan. In fact, as the letter from the city indicates, enrolling in a different Medicare Part D plan could negatively impact your city coverage. The OLR letter mentions one item that does not apply to CSA retirees in GHI Senior Care. The letter says that if you enroll in another Medicare Part D plan, you cannot participate in the city's optional rider, which includes drugs and 365 days of hospital care. CSA retirees do not have to worry about this. Under a long-standing agreement with the city, the Retiree Welfare Fund pays the premium for this rider directly to the city on behalf of CSA retirees who are in the GHI Senior Care plan (Medicare supplement). This was arranged when the premium for the drug portion of the rider was close to \$180 per month causing many retirees to switch to a spouse's plan. While the premiums have dropped, we continue this practice as a service to our retirees
